	Sunday. (Public posting no longer required)
May 15, 2024	Second sworn statement of campaign contributions or loans by candidates for membership on the
	Board of Education and Library Board to be filed with the District Clerk and Commissioner of
	Education five days prior to vote date
May 16-20, 2024	Sworn statements of campaign contributions or loans in excess of \$1,000, received before vote
	date and not previously reported, to be filed with the District Clerk and Commissioner of
	Education within twenty-four hours of receipt by candidates for membership on the Board of
	Education and Library Board
May 21, 2024	Statewide annual meeting / board election / budget vote day
June 10, 2024	Last date to file with District Clerk and Commissioner of Education final sworn statement of
